




## 1) HIV: Hepatitis C Co-Infection Protocol

HIV: HEPATITIS C CO-INFECTION PROTOC	OL/ ROLES & RESPONSIBILITIES

1) HAB Screen	AOMC
2) HCV Screen	AOMC, track by MCM
3) Refer to HCV Care, if Positive	AOMC
4) HA/B Vaccine	AOMC
5) Liver Function Test (Liver Wellness) > caveat that could be normal for some HCV+	AOMC
Below are HCV Positive	
6) Substance Abuse Assessment	AOMC/SA/MCM/EIS
7) Substance Abuse Counseling	AOMC/SA
8) Substance Abuse Treatment	SA
9) Referral by AOMC for Follow-up SA Care	AOMC

## 3) Broader discussion of 'Assessment'- brief inventory by Provider

- 1. Referral and Follow-up from HIV Medical by Medical Case Management and Specific providers such as Substance Use due to more frequent visits (to providers other than HIV Medical)
- 2. Detail in Assessment and Re-Assessment
- 3. Substance Abuse Screening in HIV Medical or Medical Case Management Arena:
  - Region 1: FHCHC, no specific tool; Haelen Center: SA/ROH/Smoking/Drug Use Tool Nathan Smith: SAMISS
  - Region 2: WHIC (SAMISS Substance Abuse and Mental Illness Symptoms Screener)
  - Region 3: GBAPP uses standardized tool for SA and specifically inquires about HABC history
  - Region 4: Family Centers uses specific tool
  - Region 5: APGD has no specific tool
- 4) Issue of Data Sharing
- 1. Need for Application of Data Sharing throughout EMA in consistent manner
- 2. Data Sharing applied to areas where clear indication that Care can be improved, Cost reduced (i.e. reduced lab testing for Hepatitis due to knowledge of prior immunity)
- 3. Accurate Count of Clients overall, and with specific conditions (i.e. HIV: HCV co-infection)
- 4. Consider standardization of Medical Case Management forms?

**CONCLUSION:** To document the HIV: HCV Co-Infection Protocol, integrate it into the Standard of Care for Ambulatory/Outpatient Medical Care (AOMC), Medical Case Management (MCM), Substance Abuse (SA) and Early Intervention Services (EIS) with review of those revised Standards at the February 3, 2012 Quality Improvement Committee meeting.
